# 3. SCHOOL CLOSING FOR WINTER HOLIDAYS ON FRIDAY, 27 JUNE 2025 @ 12:00

- On Friday, 27 June 2025, school will be closing for learners at 12:00.
- The buses will be leaving one and a half hours earlier, so please make arrangements to be at the stop one and a half hours earlier than your normal time.
- Please make arrangements for your child to be fetched at 12:00.
- Please notify your child's driver about this closing time, as in the past children have been left at the school for long periods of time, and this, as you will agree, is unacceptable.
- Do not switch your cell-phones off on these days, as we need to contact both you and the taxi driver should there be problems.
- Please also write in your child's message book the cell number of the taxi driver.
- Update all contact numbers and please send the information to the school on 26 June 2025.
- On Friday, 27 June 2025, your child should come to school with his/her school bag containing all contact details and ensure that your child's taxi drivers' cell-phone is switched on.
- Medication will be handed out at 08:00 and not at the end of the day.

#### 5. ALL LEARNERS TURNING 18 IN 2025

Parents please note that in the year that your child turns 18, he/she needs to leave the school at the end of the year. It is the parents' responsibility to find alternative placement for their child.

#### 6. GRADE 7 LEARNERS IN 2025

Learners completing Grade 7 this year, have to leave the school at the end of 2025. It is the Districts' responsibility to find alternative placement for your child. You will have to work with Forest Town School to submit relevant documentation to the District.

#### 7. LEARNERS IN WEP

At the age of 18 they will have to exit the school at the end of that year. The learner will be included in an EXIT programme during the year. It is the parents' responsibility to communicate with their child's class teacher and the Occupational Therapy Department regarding their child's exit strategy.

#### 8. EARLY ARRIVAL OF LEARNERS

Please be reminded that learners will only be supervised at the drop off point in Cowie Road from 7am. Staff begin their duty punctually and parents and drivers are to remain with the learner/ward till 7am. The parent or person dropping off the learner before 7am, will held liable for the safe-keeping of the learner till then.

#### 9. CODE OF CONDUCT FOR LEARNERS


#### 10. FOREST TOWN SCHOOL BECOMING A CASHLESS ENVIRONMENT

Forest Town School will not accept cash payments anymore. Please do not send cash with a learner or driver anymore. Please use one of the following methods:

- EFT make sure to send proof of payment to the school immediately.
- Speed point facility is available at the school for card payments.
- Pay Fast is also available on the schools' website.

#### 11. EXEMPTION FROM PAYING SCHOOL FEES IN 2025

It is the parents' responsibility to approach the school for financial assistance if school fees cannot be paid. Forms are available at the school and the parents must collect it themselves. **Parents have to apply for exemption from paying school fees every year.** 



### 12. SCHOOL FEES
